1. Demonstration

1.1 Video demonstration, digital projections etc.

Minimum royalty (tariff) for demonstration of a single visual work for **one month**.

1.2 Demonstration of diapositives

Minimum royalty (tariff) for demonstration of a single visual work for one demonstration is **EUR 0,71**.

2. To Exhibit Visual Works

Minimum royalty (tariff) for exhibition of a single visual work.

2.1 Non-commercial events

Royalty is applied if the event is of non-commercial character, no direct or indirect commercial benefit is gained.

1) Royalty for exhibition of a single work for a month.

2.3 Fairs, Festivals, City Festivities

Minimum royalty (tariff) for exhibition of a single visual work for the period indicated.

Exhibition period	Royalties, EUR
1 to 3 days	7.11
4 to 7 days	8.54
8 to 30 days	9.96
More than 30 days	7.11

If tickets are sold to the works exhibited, royalty is set **8%** of gross receipts.
