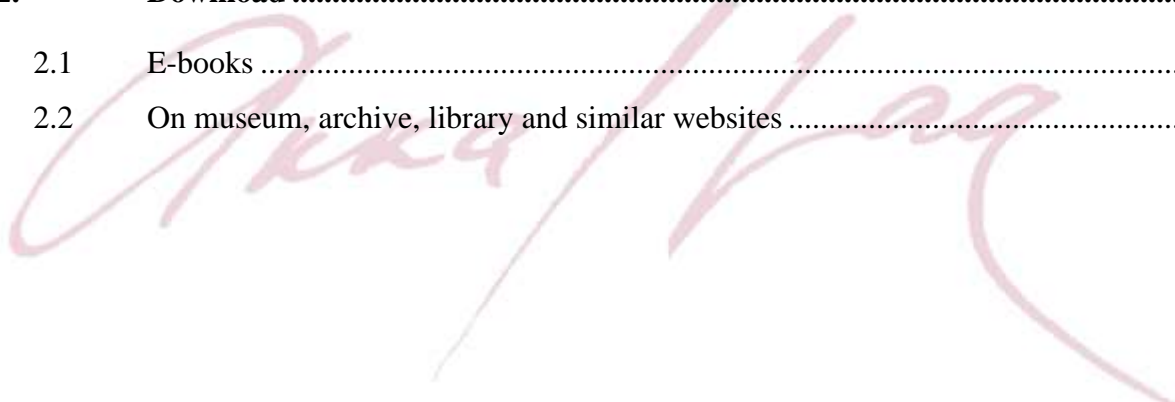

Minimum royalties (tariffs) for reproduction of visual work in one copy and making available to the public.

1. Making Available Online

Minimum royalty (tariff) for a single usage of visual work for the period indicated.

1.1 Non-commercial websites, digital tools

Minimum royalty (tariffs) for the reproduction of authors' visual works in one copy and making them available to the public on non-commercial websites and digital tools, on educational and culture establishments' (museums, archives, libraries, etc.) websites and digital tools (such as virtual exhibitions, online courses, digital materials etc).

Royalty is for websites and tools of non-commercial character, from which neither direct or indirect commercial gain is obtained and where no advertisements are placed.

1.2 Commercial websites, digital tools

Minimum royalty (tariffs) for the reproduction of authors' visual works in one copy and making them available to the public on commercial websites and digital (including press (newspapers, journals)).

Discounts:

- 1) 50% discount for press (newspapers, journals) archives.

1.3 Making available on an website and to make a reproduction

If a visual work is made available online with purpose to offer a customer to choose visual work and make a reproduction or poster for him, the royalty is:

- 1) **EUR 17,07 per year** for 1 visual work who is made available online,
- 2) **10 %** of the sales proceeds gained from each relevant reproduction or poster.

1.4 Usage of author's works in author's personal web page

AKKA/LAA license need not be obtained, if the author makes available online his own works on his personal web page.

The personal web page should meet the following three requirements:

1. The personal web page is edited and materials are made available online only by the owner or by the administrator of the web page.
2. The owner of the personal home page and the co-authors of his works are the only owners of the rights of the works made available on the web page.
3. The web page is not connected with a club, producing company, publisher or any other third party or a particular event and no economic or commercial activity is performed.

1.5 Mobile applications

Minimum royalty (tariffs) for the reproduction of authors' visual works in one copy and making them available to the public on mobile applications.

Royalty for the communication to the public of visual works is set for the term specified depending on the number of application downloads.

If a mobile application is provided and the content provider does not receive proceeds from the end user of the application, royalty for the authors of visual works made available online is as follows:

Per each additional 1000 application downloads the monthly royalty is applied.

1.6 Online digital book catalogs of libraries

If a library makes its digital book catalogs available online, the royalty for authors of visual works represented by AKKA/LAA consists of 2 parts:

- 1) royalty for reproduction of 1 edition on a publicly accessible online site is **EUR 17,00**.
- 2) royalty for 1 edition view – **EUR 0,17066**.

If not only visual, but also literary works are published in the book, the tariff specified in this paragraph is applied for the publication of all these works. Royalty is split up proportionally to the work type used.

2. Download

2.1 E-books

Download for a fee

If an e-book is offered for download, where at least one visual work by the authors represented by AKKA/LAA is included, the royalty to the visual art authors is **2 %** of the sales receipts obtained from the end user for this service, but no less than:

if the e-book contains 1-3 visual works by the authors represented by AKKA/LAA	17.07
if the e-book contains 4-6 visual works by the authors represented by AKKA/LAA	19.21
if the e-book contains 7-10 visual works by the authors represented by AKKA/LAA	21.34

If an e-book contains more than 10 visual works by the authors represented by AKKA/LAA, **EUR 0,71** is added to the basic tariff for the 11th and the next works.

An individual agreement is made on art albums and books, where the amount of visual works exceeds the amount of the text, but no less than **5 %** of the receipts received from the end users for this service.

Download for a free

If an e-book is offered for download, where at least one visual work by the authors represented by AKKA/LAA is included, and the content provider does not receive proceeds from the end users for this service, the royalty to the visual art authors is:

	EUR per year
for 100 downloads, if the e-book contains 1-3 visual works by the authors represented by AKKA/LAA	17.07

for 100 downloads, if the e-book contains 4-6 visual works by the authors represented by AKKA/LAA	19.21
for 100 downloads, if the e-book contains 7-10 visual works by the authors represented by AKKA/LAA	21.34

If an e-book contains more than 10 visual works by the authors represented by AKKA/LAA, **EUR 0,43** is added to the basic tariff for the 11th and the next works.

For every next 100 downloads the royalty for a year is applied.

An individual agreement is made on art albums and books, where the amount of visual works exceeds the amount of the text, but no less than **EUR 34,15 a year** for 1000 downloads.

2.2 On museum, archive, library and similar websites

The minimum royalties (tariffs) for the reproduction of authors' visual works and for making them available online on museums, archives, libraries, art galleries or similar websites offering virtual visual work exhibitions, or on websites developed for education and research purposes are:

- 1) if downloads is **for free** – the minimum royalty is **EUR 2,00** for one work;
- 2) if downloads is **for fee** – the royalty is **10 %** of the sum the end users have paid for one download, but no less than **EUR 2,00** for one work.

The tariff is applied only to the cases, where the number of the works placed on the mentioned websites exceeds **500 works**.

The maximum licence validity term is 3 (three) years.
