1 <u>Reproduction</u>

1.1 Reproduction in Data Storage Devices

1.1.1 Data storage devices carrying copies of audiovisual works only

Royalty is **8,5%** of the wholesale price of the movie copies reproduced.

If the recording is not reproduced for sale, the minimum royalties are applied - **EUR 0,83** shall be multiplied by the circulation of storage media.

1.1.2 Multimedia

Royalty for reproduction of an audiovisual work or its fragment in multimedia, in case when the circulation is 500 copies.

Additional royalties for each of the additional sets of **500** reproduced copies shall be equal to 25% of the original amount.¹

2 <u>Making a Work Available to the Public by Means of Integration of a</u> <u>Fragment of the Audiovisual Work into a New Work</u>

AKKA/LAA issues a license provided the rights-holder agrees to licensing of the particular kind of work under the aegis of AKKA/LAA. AKKA/LAA cannot guarantee the rights-holder's consent and permission to use the works.

When a rights-holder disagrees with the tariff stipulated by AKKA/LAA, the licensing procedure applies royalties and conditions of use upheld by the rights-holder on an individual basis.

¹ For example, a CD exploits a five-minute fragment from a movie. The royalties are **Eur 583.38** The royalties for the additional 1500 copies are (Eur 583.38)x 25%) x 3 = **Eur 437,53**

2.1 Works for the Stage

A single payment of royalties for permission to incorporate a film fragment into a work for the stage, thus creating a new independent work:

Notes:

The issued license concerns incorporation of a fragment of an audiovisual work into a work for the stage. Additionally, it is necessary to obtain a license for public performance of the audiovisual work incorporated into the work for the stage.

2.2 Integration into a New Audiovisual Work

A single payment of royalties for permission to insert a film fragment into another audiovisual work, thus creating a new independent audiovisual work:
