## 2.1 If content provider doesn't obtain proceeds from the end user

If it is possible to download for free lyrics and sheet music, which are made available online, content provider shall pay according to the quantity of use.

Minimum royalties (tariff) is for up to 1000 downloads:

#### Note:

These tariffs are for up to 1000 downloads, If more downloads are made, the tariff is multiplied by a corresponding coefficient and the multiplication is added to the base tariff, The coefficient is calculated by the dividing the number of downloads with 10 000. If 2000 downloads are made, the coefficient is 0,2, if 5000 - 0,5 etc.

#### Minimum royalty is EUR 17,- per one literary work.

### 2.2 If content provider obtains proceeds from the end user

If it is possible to download lyrics and sheet music, which are made available online, the service provider shall pay royalties of receipts<sup>1</sup> obtained from the end user for the downloading of the works:
